## **Aquatics Symposium a Success**

According to all of the positive evaluations, the first-ever NIRSA Aquatics Symposium held at Texas A&M in October was an outstanding success. There were 75 attendees at the two-day symposium, and 39 who attended the preconference Aquatic Facility Operator course.

The two presentations given by featured speaker Dr. Tom Griffiths from Penn State University were well received. One was titled, the "Seven Deadly Sins of Aquatic Facilities," and the other was "5-minute Scanning Strategy for Lifeguards."

The Aquatics Roundtable provided a format for attendees to discuss the symposium, as well as to make recommendations for future topics and sites. From this informal discussion, the consensus was: that October proved to be a good month for a symposium; it should be offered every other year; and it might include some type of certification component.

NIRSA appreciates all of the work that staff at Texas A&M University, and the Symposium Committee (Chris Denison-University of Northern Iowa, Charles Logan, Texas A&M, and Gary Pogharian-University of Tennessee) did to make this new symposium a success. It particularly appreciates the engraved plaque it received from this committee. The plaque, which lists every Aquatic Committee Chair since 1985 and has room for future updates, will be proudly displayed at the NNC.

## Attention New NIRSA Members

Have you ever wondered what the CRSS at the end of a NIRSA members' name means? It stands for Certified Recreational Sports Specialist. The certification was developed in 1982 to maintain a high level of professional competence in the field of recreational sports.

"CRSS is a means of identifying individuals who possess the necessary knowledge and expertise required in the recreational sports profession," says NIRSA Education Program Coordinator Eileen Shufelt.

Members study, then take a certification exam that covers the following subjects required in entry-level positions: programming; management and operations; risk management and legal concepts; program evaluation; participants' rights; history and philosophical foundations; and professional ethics.

The program promotes the educational standards set forth for recreational sports professionals and encourages professional growth and development. Members are urged to become certified, especially student and new members. "Certification develops a positive foundation for the profession," says Shufelt.

Application materials and a list of potential testing sites/dates are available through the NIRSA Education Department and in the Members Only section at www.nirsa.org. All registration materials and supporting documents are due at NIRSA 30 days before the proposed testing date. Exams are offered at most NIRSA sponsored events, including the Annual Conference, state and regional conferences/workshops, and various symposia. Applicants must have served two years of continuous professional or student membership in NIRSA immediately prior to apply for certification.

## **CAS Blue Book Available**

As a member of CAS (the Council for the Advancement of Standards in Higher Education), NIRSA members can now purchase the 2001 edition of *The Book of Professional Standards for Higher Education*. The 267-page volume commonly referred to as "The CAS Blue Book," contains a section on recreational sports,

In 1997, he was named as the Southern Miss Administrator of the Year. That same year, the Mississippi Chapter of the Cystic Fibrosis Foundation named him Volunteer of the Year. In 1992, Sid was the Chair of the Southern Miss United Way Campaign. He currently serves as the Financial Steward of his church.

## World AIDS Day: Dec. 1, 2001

According to the U.S. Dept. of Health and Human Services, a substantial portion of all new infections occurs under age 25 because students are often involved in at-risk activities such as the misuse of alcohol, unprotected sex, multiple sexual partners and intravenous drug use. Those who work with young people can make a huge difference by targeting this age-group with prevention education. The most important HIV-related skills young people can learn are:

- How to make good decisions about sexual relationships.
- How to identify reasons for resisting pressures for unwanted sex or drugs.
- How to recognize, avoid, or leave a situation that might turn risky or violent.
- How to find access to confidential services.
- How to discuss protected sex when ready for sexual relationships.

## The Following Ways Can Raise Awareness:

- Organize a red-ribbon week.
- Distribute fact sheets on lunch trays and tabletop displays in cafeterias/dining halls.
- Use the school newspaper to feature information on awareness.
- Hold an informal workshop on HIV/AIDS with compelling discussion questions.
- Hold a film festival featuring movies that deal with HIV/AIDS.
- Dedicate a bulletin board to AIDS awareness.
- Start a peer education program where students can educate other students.
- Distribute informational brochures to incoming freshman.
