Getting to Know the Three Separate Entities that Govern NIRSA

To accommodate the Association's continued growth, both materially and financially, three independent legal entities serve NIRSA, all with very distinct missions.

NIRSA, governed by an 11-member board of directors, is a **not-for-profit membership organization** representing approximately 4,000 individuals and organizations. It was chartered in Oregon as a "mutual benefit" corporation and has a 501(c)(6) federal tax status.

NIRSA Foundation, governed by a nine-member board, is a **not-for-profit organization** that supports the mission of NIRSA and has a 501(c)(3) tax status. Donations to the Foundation are the only tax-deductible contributions allowable to a NIRSA-related entity. Founded in 1992, the Foundation has its own Articles of Incorporation and Bylaws. The NIRSA Board has input, but it does not control the Foundation nor manage its affairs in any way. The Foundation's Board has seven members with staggered two-year terms of office, plus NIRSA's President and Executive Director. It publishes the biannual *Recreational Sports Journal* and provides opportunities through professional development, research, scholarships, educational resources, and employment assistance.

NIRSA Services Corporation (NSC), governed by a four-person board of directors, is a **wholly owned taxable subsidiary (C Corporation) of NIRSA**. NSC is a separate, but affiliated entity of NIRSA, established as a risk management tool to preserve NIRSA's tax-exempt status. It also serves to protect the assets of the Association in the event of catastrophic injury at one of its sponsored or endorsed national or regional sport events. NIRSA is the sole shareholder of NSC. The NIRSA Board of Directors appoints the NSC's BOD annually.

NSC processes unrelated business income and pays income tax on its net income. It was formed

in 1999 because gross revenues from sponsored/endorsed programs and advertising unrelated to NIRSA's tax-exempt function (by IRS definition), had grown to be a substantial part of NIRSA's income. According to the IRS, if unrelated business income (UBIT) becomes a 'significant' percentage of total revenue for a 501(c)(6) organization, such as NIRSA, its tax-exempt status can be jeopardized.

NSC handles sponsored/endorsed programs, products with an advertising component, and sport events with the possibility of catastrophic injury. The IRS considers revenue from these programs unrelated business income, except sport club championships. NSC handles the sport club championships for risk management purposes. As of November 2002, the NSC included the following programs:

There is a formal services agreement and a license agreement between NIRSA and the NIRSA Services Corporation. The agreements clarify the relationship between NIRSA and the NSC, and serve as documentation, as required by the IRS, for revenue and expense allocation between the two entities.

Honor Award Nomination and Selection Process

Deadline: December 15, 2002

The Honor Award Committee presents a member with NIRSA's highest honor "for outstanding achievements in the profession and exemplary service to the Association" during the Honor Award Banquet at the Annual Conference.

Eligibility & Criteria

The established guidelines governing nominations for this award include:

1. The candidate must be a member of NIRSA. Former members who have retired from the profession are exempt.
2. The candidate should be at least 35-years old.
3. The candidate should have at least eight years of experience in the field of recreational sports.
4. The candidate should be of fine moral character.
 - Commitment of volunteerism to professional organizations, public or community service, religious entities or other civic responsibilities
 - Ability to exemplify strong standards of ethical behavior, consistent with NIRSA's Code of Ethics
5. The candidate should have shown evidence of outstanding leadership in NIRSA and in the workplace:
 - Participating in efforts that are of significant breadth or impact to the services or programs of the Association
 - Supporting or contributing to efforts that allow the Association to move through times of transition, change, self-assessment, or planning
 - Fostering innovation or the fulfillment of new initiatives within the Association
 - Contributing to the Association's commitment to serve and recruit a diverse membership
 - Influencing, motivating or supporting the development of students, young professionals or emerging leaders in the profession

- Contributing to the learning or scholarly endeavors of others through such activity as research, assessment, teaching, presentations, or publication development
- Accomplishing goals or strategic projects, either through appointed roles or elected office within NIRSA at the institutional, state, regional or national level
- Enhancing the visibility, awareness or impact of the profession and/or the Association to other external organizations, business or governing entities, or individuals

The Honor Award Committee will evaluate nominations according to the following criteria:

- Development of students and young professionals
- Scholarly activity - teaching, presenting, publishing (instruction, presentations, research, publications)
- Leadership of a strategic or innovative nature
- Contributions to developing a diverse association
- Significant contributions to the Association
- Significant contributions in the workplace
- Ability to exemplify strong standards of ethical behavior and moral character

Additional Admirable Characteristics (can be used as a tie-breaker):

- Volunteerism with Public or Civic Organizations
- Honors and Awards

Procedure

Nominations shall be carried over for three years, and then released unless renominated.

The Services Agreement documents the expense allocation between NIRSA and NSC for labor, overhead and building costs. It was negotiated based on prevailing market rates. While the initial agreement took effect in 1999, the rates were renegotiated January 1, 2002. As market rates for these various items change, or as the number of programs NSC operates changes, the agreement will again be renegotiated. The President of NIRSA and the President of NSC sign the agreement.

The components of the current agreement (January 1, 2002) are as follows:

Financial Administration & Payroll for the NIRSA Services Corporation (NSC)

NIRSA handles all payroll administration and then bills NSC monthly for its share of direct labor expenses. Direct labor is billed at agreed upon hourly rates for affected employees. Hourly rates were negotiated based on current market rates, and time allocation ratios for various positions. NIRSA employees complete timesheets that are applied at month's end for labor billing from NIRSA to NSC. For budgeting purposes, we estimate the amount of time that affected employees are expected to spend on various NSC programs during the course of the year. Indirect labor, such as receptionist, clerical assistance, and supervision, is included at a flat rate in the services/administration amount.

A License Agreement gives NSC the right to use NIRSA's mark (brand and logo) in the marketing and promotion of intramural and extramural sports events, contests and programs. In return for this right, NSC pays NIRSA a royalty fee equal to 7.5 percent of all gross revenues for any activity in which the mark is used. Although the NSC organizes, promotes and administers certain events, the good will and reputation of NIRSA (through the use of NIRSA's mark), enhances these events.
